Commander's Comments

Warriors, it's been a while since I've written anything for the Wing's Afterburner. Glad to be back! I thought I'd write about where we are as a Wing, our future, and your dedication.

I was brought back to the Wing as the Operations Group Commander in January, just in time to join the Sentry Aloha deployment for fighter integration training with the Hawaii Air National Guard's F-22 Raptors. There we flew against the F-16 Aggressor Squadron from Eielson Air Force Base, Alaska. It was a hugely successful exercise because of the teamwork of all those involved.

Shortly thereafter, we deployed to Red Flag 18-2 at Nellis AFB, Nevada, which was also very successful because of your hard work and dedication.

This past week the wing engaged in late night, large force employment exercises practicing the "adaptive basing" concept for full spectrum readiness.

In late summer, we'll be deploying for more fighter integration training with our active duty counter-parts. In the fall, we'll deploy with other Air Guard units in support of the State Partnership Program followed immediately by an exercise with U.S. Air Forces Europe before returning home.

Back at the 144th FW, we recently had an Alert Force Operational Assessment, and will have an Alert Force Evaluation later this summer.

The F-15 pilots and maintainers were not the only ones operating at peak proficiency, our RC-26 crews had a very busy 2017 with responses to massive flooding up north and then fire mapping last fall in Sonoma, Lake, Napa, Mendocino, and Ventura counties. Additionally, they answered the call during the hurricane emergencies in Texas to aid with damage assessment and personal recovery.

Many other squadrons had personnel activated last year to assist with the North Bay and Ventura fires. The activated Airmen performed duties ranging from security and logistics to personnel and finance functions, most of them working side by side with their Army National Guard counter-parts.

Our plate is full! All of what I just wrote about is in fulfillment of our three core missions: prepare for worldwide deployment to establish Air Superiority, flawlessly perform the 24/7/365 mission of Aerospace Control Alert, and support

the State of California (and other U.S. States and Territories) with civil support. We wouldn't be able to have any of this success if it weren't for you and your dedication!

A couple months ago I addressed the pilots about the concept of dedication, specifically with regard to advice Gen. Carl Spatz gave to Brig. Gen. Robin Olds (then Maj. Olds) at the end of WWII in Europe. During a mentoring session in England, Gen. Spatz described four types of people, or personality traits, to Maj. Olds, and warned him of three of the traits. However, the forth type of person, the DEDICATED, is what Spatz told Olds to surround himself with. Specifically, Spatz said with regard to the DEDICATED, "Stick with them, search them out, and work hard to be worthy of their company."

We have a righteous mission. You are doing fantastic work. Much is being asked of you, and we will continue to ask it of you. Let's continue traveling on this upward vector! You have proven, and continue to prove that you are the DEDICATED. I am taking Gen. Spatz's advice: I have searched you out, I am sticking with you for the rest of my career, and I will work hard to be worthy of your company.



Chief's Corner

Why do today what you can put off till tomorrow? Words spoken from a true procrastinator. Are all your legal affairs in order in the event you have to deploy? If not, you should read this ... and if so ... you should read it anyway.

This short article is not intended to be an all-inclusive checklist, but a reminder that it is important to prepare your family for your deployment. Sometimes we forget that any one of us can be called to duty at a moment's notice. That is why it is very important to take the time now to prepare your family for deployment as well. And for all you "single" people thinking "this doesn't apply to me" ... it IS important for you too.

I know everyone cringes when the First Sergeant brings up all the overdue family plans, but this is a very easy and quick item to complete. If you haven't already done so, take the time to see your First Sergeant to complete.

The next item should be a power of attorney. This document allows a person you trust, called your agent, to make transactions and take care of business that would normally require your signature (things like cashing checks, bank transactions, filing taxes, etc. etc.)

No one wants to think about this, but it is also very important to complete ASAP. A living and last will and testament or living trust (whichever works best for your situation). Although it may not be mandatory, it is the only way to guarantee things to be settled as you wish should something terrible happen. We, in the military, have the unique opportunity to use resources to help us complete those items.

Other documents that I would recommend having ready and available for your spouse or family are marriage and family documents, insurance policies, and property paperwork.

Be sure to have important documents collected in one location. Whether you are a technogeek, and digitize all your important documents or old-school and keep hard copies, make sure you protect them for security purposes, but not to the point where your family can't get to them either. I recommend keeping all your important documents organized, filed, and labeled in a safe place like a fire-proof safe.

If you start working on some of these things now, it will be a lot easier to complete than you think. If you procrastinate, you will find that it will slowly drop to the bottom of your short term priority list, and will not get done prior to your deployment ... or the next one ... or you get the point.

EOD Prepares and Disarms

FRESNO, Calif.— The 144th Fighter Wing Explosives Ordinance Disposal Unit participated in a training exercise with the Department of Homeland Security and other local law enforcement agencies in Fresno, California, April 18 and 19, 2018.

Participants included members of the 144th Fighter Wing, the Fresno County Sheriff, the Fresno Police Department, the Clovis Police Department, and the Merced Police Department among other agencies from around Central California.

Homeland Security personnel set up a series of scenarios for the different agencies to work through together.

"We went out to a rail yard and trained with local authorities from around the Central Valley," said U.S. Air Force Master Sgt. Charles Greer, 144th Civil Engineer Squadron EOD technician. "One of the scenarios was that a suspect tossed a bag of pipe bombs into the cabin of the rail car. It was our job to remove it safely and disable the device."

Scenarios such as these help open communications between the different agencies, which in turn increases readiness for the 144th EOD team to respond situation beyond the Fresno Air National Guard Base.

"Our mission for the 144th is supporting the aircraft and the munitions that it carriers," said Master Sgt. Greer. "When deployed we may have to deal with improvised explosive devices. We are continually training to prepare for real world events."

A Long Overdue Homecoming


A visit from a Facility Therapy dog can break the daily routine, increase overall emotional well-being, and stimulate the mind in dramatic ways. Facility Therapy dogs offer so many wonderful benefits to people of all ages such as:

- -Bringing joy and laughter, even if for a short time
- -Taking a person's mind off of personal problems, aches, pains and worries
- -Getting people to share their emotions and stories
- -Giving a chance for people to communicate with others
- -Lowering stress levels and blood pressure
- -Rekindling warm memories of their pets

Researchers and experts agree that pets excel as therapeutic agents and that dogs are an antidote to depression. Studies have shown a decrease in both blood pressure and stress levels during therapy dog visits.


